

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Endorsing Arizona State Representative Jennifer Burns for Arizona State Representative)

RESOLUTION NO. 04-527

1 WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation  
2 members participating in the democratic process as citizens of the United States of  
3 America; and

4 WHEREAS, the Republican candidate for Arizona State Representative, District 25, Jennifer  
5 Burns has been supportive of tribal governments; and

6 WHEREAS, Representative Burns has voiced her desire to maintain and enhance the  
7 relationship between the Tohono O'odham Nation and her office.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation endorses the Republican  
9 candidate for Arizona State Representative, District 25, Representative Jennifer  
10 Burns.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup> Day  
12 of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 1,385.2 FOR; 166.3  
13 AGAINST; 714.1 NOT VOTING; and 364.1[05] ABSENT, pursuant to the powers vested in the Council  
14 by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
15 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
17 18, 1934 (48 Stat. 984).
