

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Cultural Affairs - Nation's Reburial Ceremony Budget FY 04 Carry Over &**  
**Modification No. 1 for FY 05)**

**RESOLUTION NO. 04-530**

1 **WHEREAS, the Tohono O'odham Nation Members uphold and respect the Culture, Traditions**  
2 **and Heritage from the Ancestral Past; and**

3 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 2000-275**  
4 **appropriating funds for the Cultural Center Museum; and**

5 **WHEREAS, the Tohono O'odham Legislative Council acknowledged that there is need to provide**  
6 **funding to assist the Nation's Annual Reburial Ceremony which takes place in**  
7 **November of every year; and**

8 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 03-487 approving a**  
9 **budget of \$10,000 for the Nation's Annual Reburial Ceremony in FY 04, taking the**  
10 **funding from the Cultural Center Museum Reserve; and**

11 **WHEREAS, for FY 04, a total of \$2,859.30 was expended in support of the Nation's Annual Reburial**  
12 **Ceremony, leaving a balance of \$7,140.70.**

13 **NOW, THEREFORE, BE IT RESOLVED that:**

- 14           **1. The Tohono O'odham Legislative Council approves that the remaining funds**  
15 **from the FY 04 Nation's Reburial Ceremony Budget (\$7,140.70) is carried over to**  
16 **provide funding for the Nation's Annual Reburial Ceremony in FY 05.**
- 17           **2. The Tohono O'odham Legislative Council approves that any remaining funds**  
18 **beyond FY 05 will be carried over and expended until exhausted.**
- 19           **3. The Tohono O'odham Legislative Council approves by this resolution a budget**  
20 **modification from the original FY 04 for FY 05 that permits funds to be**  
21 **redistributed within the existing budget (\$7,140.70) to cover costs for program**  
22 **supplies (722), lease rentals (751), professional services (810) and food (850) as**  
23 **described in attached budget form.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup> Day**  
25 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,074.2 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and 555.5 [07] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**


