

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting a Basic Grant for the Venito Garcia Library and Archives from the Institute of Museum and Library Services)**

**RESOLUTION NO. 04-537**

1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**  
2 **Library and Archives, the library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Venito Garcia Library and Archives is charged with library development for the**  
4 **Tohono O'odham Nation; and**

5 **WHEREAS, the Venito Garcia Library and Archives has received this grant annually since 2000**  
6 **from IMLS (Institute of Museum and Library Services, the primary library funding**  
7 **agency of the U.S. Federal government) through its Native American Library Services**  
8 **division.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**  
10 **Basic Grant from IMLS for library services and supplies for the amount of \$4,000, and**  
11 **authorizes the use of these funds by the Venito Garcia Library and Archives, and**  
12 **waives indirect costs which is a requirement of this particular grant.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup> Day**  
14 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
17 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
18 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
19 **Stat. 984).**


