RESOLUTION NO. 04-538

1 **WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation**
2 **members participating in the democratic process as citizens of the United States of**
3 **America; and**

4 **WHEREAS, the 2004 election serves to be an important election for the state of Arizona and the**
5 **Tohono O'odham Nation has began a "Get Out the Vote Project"; and**

6 **WHEREAS, the Executive Office applied for seed money from the National Congress of American**
7 **Indians who was soliciting grant applications from tribes and organizations to assist**
8 **with voter registration and voter mobilization efforts; and**

9 **WHEREAS, the Tohono O'odham Nation has been awarded \$10,000.00 from NCAI for theGet out**
10 **the Vote Project.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
12 **NCAI Education fund in the amount of \$10,000.00.**

13 **BE IT FINALLY RESOLVED that the Executive Office is authorized to expend the funds in accordance**
14 **with the approved budget.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH Day**
16 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**


