(Approval of Pisinemo District FY 2005 Budget)

RESOLUTION NO. 04-544

1 **WHEREAS, at a regularly scheduled session of the Legislative Council, Pisinemo District did**
2 **present the District Operating Budget for Fiscal Year 2005 in the amount of**
3 **\$683,893.19; and**

4 **WHEREAS, the Tohono O'odham Legislative Council did review the proposal of Pisinemo District;**
5 **and**

6 **WHEREAS, Pisinemo District Council did approve their FY 2005 Budget through District**
7 **Resolution No. 2004-18 dated October 12, 2004.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve**
9 **the FY 2005 Operating Budget of the Pisinemo District in the amount of \$683,893.19**
10 **and authorizes employee compensation adjustment to be retroactive to October 1,**
11 **2004.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
13 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
14 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**


