(Accepting funds in the amount of \$25,000.00 for Youth Transportation Art Grant)

RESOLUTION NO. 04-546

1 WHEREAS, the Planning Department's Transportation Program received additional funding in
2 the amount of \$25,000.00 for the Youth Transportation Art Project; and
3 WHEREAS, the amount received now brings the total budget to \$50,000.00 and would amend the
4 budget; and
5 WHEREAS, the Project is funded by a grant from the Pima Association of Governments which is
6 to enhance community pride by involving the District youth in designing public
7 transportation art; and
8 WHEREAS, the Planning Department is requesting approval and acceptance of the funds in the
9 amount of \$25,000.00; and
10 WHEREAS, the grant will be administered by the Planning Department Administration.
11 NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby accepts the
12 additional fund amount of \$25,000.00 and approves the attached budget amendment
13 for a total of \$50,000.00.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day
15 of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-
16 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
18 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
20 Stat. 984).


