

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with California Indian Legal Services)**

RESOLUTION NO. 04-549

1 **WHEREAS, pursuant to Legislative Council Resolution 04-082, the Nation entered into an**
2 **Attorney Contract with California Indian Legal Services (the "Attorneys") for Fiscal**
3 **Year 2004, for the purpose of providing legal representation to protect the Nation's**
4 **interests under the Indian Child Welfare Act in connection with legal proceedings in**
5 **the State of California; and**

6 **WHEREAS, the Attorney Contract expired on September 30, 2004; and**

7 **WHEREAS, continued representation is necessary to protect the Nation's interests in these**
8 **proceedings; and**

9 **WHEREAS, the Attorney General has proposed an Attorney Contract with California Indian Legal**
10 **Services for Fiscal Year 2005, in the amount of \$80,000, a copy of which is attached**
11 **hereto; and**


12 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval by the**
13 **Legislative Council of an Attorney Contract with the Attorneys on such terms.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
16 **with California Indian Legal Services in the amount of \$80,000 for Fiscal Year**
17 **2005, in the form attached hereto.**
- 18 **2. Funding for the Attorney Contract shall be provided from the operating budget**
19 **of the Office of Attorney General.**
- 20 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
21 **Contract.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. Day**
23 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
