

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

**(Approving Attorney Contract with Gilmore & Turner, P.L.L.C., Relating to Indian Child Welfare Act Proceedings in Pima County Juvenile Court)**

**RESOLUTION NO. 04-550**

1 **WHEREAS, additional representation is required to adequately protect the interests of the**  
2 **Tohono O'odham Nation (the "Nation") in proceedings under the Indian Child Welfare**  
3 **Act which are pending in Pima County Juvenile Court; and**

4 **WHEREAS, the Attorney General recommends the engagement of the law firm of Gilmore &**  
5 **Turner, P.L.L.C. (the "Attorneys") to provide such representation under an Attorney**  
6 **Contract in the amount of \$25,000 for Fiscal Year 2005; and**

7 **WHEREAS, the budget of the Office of Attorney General (01-1031-810) has sufficient funds for the**  
8 **Contract amount; and**

9 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval of the**  
10 **Attorney Contract by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that:**

- 12           1. **The Tohono O'odham Legislative Council approves the Attorney Contract with**  
13 **the Attorneys in the amount of \$25,000 for Fiscal Year 2005, in the form attached**  
14 **hereto.**
- 15           2. **Funding for the Attorney Contract shall be provided from the budget of the Office**  
16 **of Attorney General (01-1031-810).**
- 17           3. **The Chairwoman of the Nation is authorized and directed to execute the Attorney**  
18 **Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
20 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,376.1 FOR; 126.80**  
21 **AGAINST; 126.80 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
