

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of Quigley & Whitehill, P.L.C.)**

RESOLUTION NO. 04-552

1 **WHEREAS, pursuant to Resolution No. 04-084, the Tohono O'odham Nation ("Nation") approved**
2 **an Attorney Contract with the law firm of Quigley & Whitehill, P.L.C. (the "Attorneys")**
3 **for Fiscal Year 2004, to provide legal representation to the Nation in connection with**
4 **litigation and negotiations related to the Central Arizona Project (CAP); and**

5 **WHEREAS, the Attorney Contract expired on September 30, 2004; and**

6 **WHEREAS, the Attorney General has proposed an attorney contract with the Attorneys for Fiscal**
7 **Year 2005 in the amount of \$5,000, a copy of which is attached hereto; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees recommend approval by**
9 **the Legislative Council of the Attorney Contract.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract in the**
12 **amount of \$5,000 for Fiscal Year 2005 in the form attached hereto.**
- 13 **2. Funding for the Attorney Contract shall be provided from the operating budget**
14 **of the Office of Attorney General.**
- 15 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**
16 **Contract.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
18 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,502.9 FOR; -0-**
19 **AGAINST; 126.80 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
