

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Attorney Contract with Slosser, Hudgins, Struse & Freund Related**  
**to Initiative (No. IN-01-97))**

**RESOLUTION NO. 04-555**

1 **WHEREAS, pursuant to Legislative Council Resolution 03-510, the Nation entered into an**  
2 **Attorney Contract with Slosser, Hudgins, Struse & Freund (the "Attorneys") for the**  
3 **purpose of providing legal representation to the Nation with respect to the tax**  
4 **implications for the Nation and its members associated with the implementation of**  
5 **an Initiative (No. IN-01-97) approved by the voters of the Nation on June 28, 1997; and**

6 **WHEREAS, the Attorney Contract expired on September 30, 2004; and**

7 **WHEREAS, continued representation is necessary to protect the Nation's interests in these**  
8 **matters; and**

9 **WHEREAS, the Attorney General has proposed an Attorney Contract with the Attorneys for Fiscal**  
10 **Year 2005 in the amount of \$12,500; and**

11 **WHEREAS, the Fiscal Year 2005 budget for Initiative Legal Research (24-1809-810) approved by**  
12 **the Legislative Council has sufficient funds for an Attorney Contract in the amount**  
13 **of \$12,500; and**

14 **WHEREAS, the Domestic Affairs and Budget & Finance Committees recommend approval of the**  
15 **Attorney Contract by the Legislative Council.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 17 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**  
18 **with Slosser, Hudgins, Struse & Freund for fiscal year 2005 in the amount of**  
19 **\$12,500 and in the form attached hereto.**
- 20 **2. Funding for the Attorney Contract shall be provided from the Initiative Legal**  
21 **Research budget (24-1809-810) for Fiscal Year 2005.**
- 22 **3. The Chairwoman of the Nation is authorized and directed to execute the Attorney**  
23 **Contract.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
25 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 1,589.65 FOR; 910.6**  
26 **AGAINST; 129.45 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
30 **Stat. 984).**
