

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 04-520, "Supporting a "NO" Vote on Proposition 200")**

RESOLUTION NO. 04-559

1 **WHEREAS, the Tohono O'odham Nation recognizes the importance of Tohono O'odham Nation**
2 **members participating in the democratic process as citizens of the United States of**
3 **America; and**

4 **WHEREAS, a "YES" vote on Proposition 200 shall have the effect of [1] requiring a person to**
5 **submit evidence of United States citizenship when registering to vote, [2] requiring**
6 **the county recorder to reject any voter registration that is not accompanied by proof**
7 **of citizenship, [3] requiring voters to present a photo identification with name and**
8 **address or two other forms of identification with name and address before receiving**
9 **a ballot at the polling place, [4] requiring state and local governments to verify the**
10 **identity and eligibility of applicants for state and local public benefits that are not**
11 **federally mandated, [5] requiring government employees to report violations of**
12 **United States immigration law by applications for public benefits, [6] making it a**
13 **class 2 misdemeanor if a government employee fails to make the required report and**
14 **[7] permitting private lawsuits by any resident to enforce provisions relating to public**
15 **benefits; and**

16 **WHEREAS, a "YES" vote will negatively effect the members of the Tohono O'odham Nation.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation supports a "NO" Vote on**
18 **Proposition 200.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. Day**
20 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
