1	WHEREAS,	the Tohono O'odham Legislative Council has adopted Resolution No. 04-062,
2		approving an attorney contract with the law firm of Holland & Knight LLP for the
3		purpose of providing legal consulting services to the Nation for matters involving
4		federal legislative, administrative, appropriations, lobbying and agency
5		representation, and general legal representation; and
6	WHEREAS,	Resolution No. 04-062 approves the contract period to commence February 20, 2004
7		and to expire September 30, 2004; and
8	WHERAS,	the said contract has expired and there exists a need for continued service from the
9	·	law firm of Holland & Knight LLP to the Tohono O'odham Nation to monitor and
10		secure appropriation requests, resources and continue to represent the best
11		interests of the Nation during the final days of the 108 <sup>th</sup> Congress; and
12	WHEREAS,	the approved contract allows for contract extension under Section XIII-Term
13		subsection A & B that is contingent upon the availability of appropriated funds; and
14	WHEREAS,	Resolution No. 04-043 has appropriated \$576,000.00 for Lobby and Public Relations
15		Services for FY 2004 ending September 30, 2004 of which expenditures made under
16		the contract with Holland & Knight LLP were debited; and
17	WHEREAS,	the identified account established for Lobby & Public Relations for the Tohono
18		O'odham Nation is the General Account; and
19	WHEREAS,	the Tohono O'odham Nation Executive Branch presently is operating under
20		Resolution No. 04-452 FY 2004 continuing authorization for the period of October 1,
21		2004 through November 30, 2004; and
22	WHEREAS,	the October 1, 2004 – November 30, 2004 period provides for \$96,000.00.
23	WHEREAS,	the Chairwoman of the Nation has met with the Legislative Budget & Finance
24		Committee and to discuss and agree upon the amendment of the Holland & Knight
25		LLP contract until such time that the Legislative Appropriations Committee and
26		Executive can meet to discuss further lobbying needs of the Nation.
