

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appointing Nancy Garcia to the Election Board)**

RESOLUTION NO. 04-561

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint members**  
2 **of the Tohono O'odham Election Board pursuant to Section 1 (B) of Article 11 of**  
3 **Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance"), which**  
4 **states, "Members of the Election Board shall be appointed by the Tohono O'odham**  
5 **Council for terms of five years, or until their successors are appointed and qualified;**  
6 **and**

7 **WHEREAS, the Election Ordinance further requires "that appointments to the board shall be**  
8 **made in such a way and for such terms that their terms shall be staggered so that the**  
9 **term of office of only one member will end in any single year;" and**

10 **WHEREAS, effective July 31, 2004, Election Board Member Mary Jane Juan-Moore's term did**  
11 **expire and she continues to serve as a Board member until her successor is**  
12 **appointed; and**


13 **WHEREAS, the Rules Committee, having legislative oversight over the Election Board, has**  
14 **solicited and interviewed qualified bilingual members of the Nation to fill this seat**  
15 **on the Election Board; and**

16 **WHEREAS, the Rules Committee recommends that Nancy Garcia be appointed to the Election**  
17 **Board to complete the five-year term ending July 31, 2009.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby appoints Nancy Garcia**  
19 **as a member of the Election Board to complete the five (5) year term ending July 31,**  
20 **2009.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> Day**  
22 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 1,621.2 FOR; 1,008.5**  
23 **AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Section**  
24 **1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
