

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 04-053, "Appointing Priscilla Domingo to the Tohono
O'odham Enrollment Committee")

RESOLUTION NO. 04-563

1 WHEREAS, the Ordinance for the Tohono O'odham Nation regulating enrollment in the Tohono
2 O'odham Nation, Ordinance No. 5-81, as amended, calls for the appointment of
3 committee members to the Tohono O'odham Enrollment Committee; and

4 WHEREAS, the Chairwoman of the Nation has appointed Priscilla Domingo to serve as a member
5 of the Tohono O'odham Enrollment Committee, per Resolution No. 04-053; and

6 WHEREAS, Priscilla Domingo currently is serving as a member of the Tohono O'odham
7 Enrollment Committee; and

8 WHEREAS, concerns were raised regarding the performance of duties as a committee member.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council rescinds the
10 appointment of Priscilla Domingo to serve as a member of the Tohono O'odham
11 Enrollment Committee.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND Day
13 of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,012.65 FOR; 182.05
14 AGAINST; 435.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).
