

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Rescinding Resolution No. 04-051, "Appointing Carmelita Mattias to the Tohono  
O'odham Enrollment Committee")**

**RESOLUTION NO. 04-564**

1 **WHEREAS, the Ordinance for the Tohono O'odham Nation regulating enrollment in the Tohono**  
2 **O'odham Nation, Ordinance No. 5-81, as amended, calls for the appointment of**  
3 **committee members to the Tohono O'odham Enrollment Committee; and**  
4 **WHEREAS, the Chairwoman of the Nation has appointed Carmelita Mattias to serve as a member**  
5 **of the Tohono O'odham Enrollment Committee, per Resolution No. 04-051; and**  
6 **WHEREAS, Carmelita Mattias currently is serving as a member of the Tohono O'odham**  
7 **Enrollment Committee; and**  
8 **WHEREAS, concerns were raised regarding the performance of duties as a committee member.**  
9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council rescinds the**  
10 **appointment of Carmelita Mattias to serve as a member of the Tohono O'odham**  
11 **Enrollment Committee.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> Day**  
13 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 1,741.55 FOR; 269.75**  
14 **AGAINST; 618.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
15 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
18 **18, 1934 (48 Stat. 984).**
