

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY-2005 Budget for the Tohono O'odham Nation Vocational Rehabilitation Program, Grant Award #H250D030012)

RESOLUTION NO. 04-568

1 **WHEREAS, the Tohono O'odham Nation, upon enactment of Resolution No. 03-512, did accept a**
2 **5 year grant, beginning October 1, 2003 to September 30, 2008, from the U.S.**
3 **Department of Education, Rehabilitation Service Administration's Section 121**
4 **(Vocational Rehabilitation Services Projects for American Indians with Disabilities)**
5 **under P.L. 102-569 Rehabilitation Act of 1973 as amended; and**

6 **WHEREAS, services under the Tohono O'odham Nation Vocational Rehabilitation Program will**
7 **be provided to eligible enrolled members of the Tohono O'odham Nation and other**
8 **federally recognized Native Americans living on the Nation with disabilities; and**


9 **WHEREAS, the Tohono O'odham Nation, Department of Education will contribute the required**
10 **10% match from the Education budget; and**

11 **WHEREAS, the Vocational Rehabilitation Program has developed the FY-2005 budget in the**
12 **amount of \$400,000.00 beginning October 1, 2004 through September 30, 2005 and is**
13 **seeking approval of the attached budget.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
15 **approves the Vocational Rehabilitation Program's FY-2005 budget in the amount of**
16 **\$400,000.00 and hereby authorizes expenditure of the funds for the period of October**
17 **1, 2004 through September 30, 2005.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day**
19 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 1,755.35 FOR; 874.35**
20 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
