

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 04-389, "Amending the Accounting and Administrative
Provisions - Audit Budgets; Transfer of \$90,000 to provide for additional
audit services")

RESOLUTION NO. 04-571

1 **WHEREAS, the Tohono O'odham Legislative Council did provide for appropriations for the**
2 **Executive Branch's Accounting Department and Administrative Provisions - Audit for**
3 **FY 2004 operations; and**

4 **WHEREAS, the Executive Branch has determined that audit services will exceed the available**
5 **appropriation authorized for audit services as the Nation has incorporated the**
6 **districts into their audit plan; and**

7 **WHEREAS, sufficient savings have been identified in the Accounting Department's operating**
8 **budget that can be transferred to the Administrative Provisions - Audit budget to**
9 **provide for the additional services required; and**

10 **WHEREAS, the Executive Branch has prepared budget amendments to both of the Accounting**
11 **Department and Administrative Provisions - Audit operating budgets, attached and**
12 **incorporated into this resolution by this reference, and has presented these**
13 **amendments to the Legislative Oversight Committees.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
15 **hereby:**

- 16 **1. Approve of the budget amendments presented, attached and incorporated into**
17 **this resolution by this reference, transferring \$90,000 from the Accounting**
18 **Department's FY 2004 operating budget to the Administrative Provisions - Audit**
19 **FY 2004 operating budget.**
- 20 **2. This transfer does not affect the operating base of the Accounting Department.**
- 21 **3. That the Executive Office and the Budget & Finance Committee, in cooperation**
22 **with each District, work towards addressing the audit questions raised in each**
23 **respective District audit and report to the Tohono O'odham Legislative Council**
24 **at its December 2004 General Session as to the status of each audit finding.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
26 **of OCTOBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**
27 **AGAINST; 166.3 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
