1	WHEREAS,	during the October 22, 2004 General Session of the Tohono O'odham Legislative					
2		Council, the Council did pass Resolution No. 04-565, <i>"Rescinding Resolution No. 04-</i>					
3		052, 'Appointing Emily Fasthorse to the Tohono O'odham Enrollment Committee''';

5	WHEREAS,	upon presentation of Resolution No. 04-565 to the Chairwoman of the Tohono					
6		O'odham Nation, she did disapprove thereof and returned it to the Council with her					
7		objections in accordance with the provisions of Article VII, Section 5 of the					
8		Constitution of the Tohono O'odham Nation; and					
9	WHEREAS,	during the November 01, 2004 General Session, the Chairwoman of the Nation					
10		presented to the Legislative Council her justification in vetoing Resolution No. 04-					
11		565, a copy of which is attached hereto; and					
12	WHEREAS,	the Legislative Council reviewed the Chairwoman's objections and after					
13		consideration, again voted to pass Resolution No. 04-565.					
14	NOW, THER	DW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby					
15		override the Chairwoman's veto of Resolution No. 04-565 by a vote of two-thirds of the					
16		votes cast in accordance with the provisions of Article VII, Section 5 of the					
17		Constitution of the Tohono O'odham Nation.					
18 19 20 21 22 23	The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the <u>01<sup>s1</sup> day of NOVEMBER, 2004</u> at a meeting at which a quorum was present, and by a vote of <u>1,846.35</u> FOR; <u>348.35</u> AGAINST; <u>435.0</u> NOT VOTING; and <u>[02]</u> ABSENT, was passed by a majority of at least two- thirds (2/3) <u>[1,753.13]</u> of the votes cast as required by Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
