(Override of Vetoed Resolution No. 04-565, "Rescinding Resolution No. 04-052, 'Appointing Emily Fasthorse to the Tohono O'odham Enrollment Committee'")

RESOLUTION NO. 04-576

1 **WHEREAS, during the October 22, 2004 General Session of the Tohono O'odham Legislative**
2 **Council, the Council did pass Resolution No. 04-565, "Rescinding Resolution No. 04-**
3 **052, 'Appointing Emily Fasthorse to the Tohono O'odham Enrollment Committee'";**
4 **and**

5 **WHEREAS, upon presentation of Resolution No. 04-565 to the Chairwoman of the Tohono**
6 **O'odham Nation, she did disapprove thereof and returned it to the Council with her**
7 **objections in accordance with the provisions of Article VII, Section 5 of the**
8 **Constitution of the Tohono O'odham Nation; and**

9 **WHEREAS, during the November 01, 2004 General Session, the Chairwoman of the Nation**
10 **presented to the Legislative Council her justification in vetoing Resolution No. 04-**
11 **565, a copy of which is attached hereto; and**

12 **WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after**
13 **consideration, again voted to pass Resolution No. 04-565.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **override the Chairwoman's veto of Resolution No. 04-565 by a vote of two-thirds of the**
16 **votes cast in accordance with the provisions of Article VII, Section 5 of the**
17 **Constitution of the Tohono O'odham Nation.**

18 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 01ST**
19 **day of NOVEMBER, 2004 at a meeting at which a quorum was present, and by a vote of 1,846.35**
20 **FOR; 348.35 AGAINST; 435.0 NOT VOTING; and [02] ABSENT, was passed by a majority of at least two-**
21 **thirds (2/3) [1,753.13] of the votes cast as required by Section 5 of Article VII of the Constitution of**
22 **the Tohono O'Odham Nation.**
