

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override of Vetoed Resolution No. 04-566, "*Rescinding Resolution #2004-064, 'Appointing Clarence Miguel to the Tohono O'odham Enrollment Committee'*")

FAILED
RESOLUTION NO. 04-577

1 WHEREAS, during the October 22, 2004 General Session of the Tohono O'odham Legislative
2 Council, the Council did pass Resolution No. 04-566, "*Rescinding Resolution #2004-*
3 *064, 'Appointing Clarence Miguel to the Tohono O'odham Enrollment Committee'*";
4 and

5 WHEREAS, upon presentation of Resolution No. 04-566 to the Chairwoman of the Tohono
6 O'odham Nation, she did disapprove thereof and returned it to the Council with her
7 objections in accordance with the provisions of Article VII, Section 5 of the
8 Constitution of the Tohono O'odham Nation; and


9 WHEREAS, during the November 01, 2004 General Session, the Chairwoman of the Nation
10 presented to the Legislative Council the justification in vetoing Resolution No. 04-
11 566, a copy of which is attached hereto; and

12 WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after
13 consideration, again voted to pass Resolution No. 04-566.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
15 override the Chairwoman's veto of Resolution No. 04-566 by a vote of two-thirds of the
16 votes cast in accordance with the provisions of Article VII, Section 5 of the
17 Constitution of the Tohono O'odham Nation.

18 The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 01ST
19 day of NOVEMBER, 2004 at a meeting at which a quorum was present, and by a vote of 1,076.95
20 FOR; 926.35 AGAINST; 626.4 NOT VOTING; and [03] ABSENT, failed to pass because it did not receive
21 a majority of two-thirds (2/3) [1,753.13] of the votes cast as required by Section 5 of Article VII of
22 the Constitution of the Tohono O'Odham Nation.
