

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Granting Permission for Mr. Stephen Mack to Write Two Books
about Tohono O'odham Culture and History)

RESOLUTION NO. 04-584

1 **WHEREAS, Mr. Stephen Mack, a member of the Tohono O'odham Nation came before the Tohono**
2 **O'odham Legislative Council on June 9, 2004 and presented his proposal and also**
3 **seeking permission to write two books about Tohono O'odham culture and history;**
4 **and**

5 **WHEREAS, the Tohono O'odham Legislative Council advised Mr. Mack to present his proposal**
6 **to the Districts for comments; and**

7 **WHEREAS Mr. Mack has made every effort to contact all the Districts at which the majority of the**
8 **Districts are in support of the proposal; and**

9 **WHEREAS, Mr. Mack wants to make a contribution towards a cultural bridge in the form of two**
10 **books, these books will present Tohono O'odham culture and history in an accurate**
11 **and respectful manner; and**

12 **WHEREAS, Mr. Mack also presented his proposal to the Cultural Preservation Committee and to**
13 **Human Resources Development Committee which both committees support.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **grant permission and approves Mr. Stephen Mack's proposal to write and publish two**
16 **books about Tohono O'odham culture and history.**

17 **BE IT FURTHER RESOLVED THAT with the understanding that before either book is printed, the**
18 **author Mr. Stephen Mack will make preliminary copies available for review to the**
19 **Cultural Preservation Committee, Human Resources Development Committee, the**
20 **Legislative Council, Chairwoman of the Nation, District Chairpersons, and any others**
21 **that the Legislative Council deems appropriate. These groups will have the authority**
22 **to remove any photograph, images, or statements from the books that are considered**
23 **culturally sensitive.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 3RD Day**
25 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,238.25 FOR; -0-**
26 **AGAINST; 391.45 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
