(Rescinding Legislative Order No. 04-201, "Certifying the Appointment of Rosita N. Ruiz as Legislative Council Secretary")

LEGISLATIVE ORDER NO. <u>04-586</u>

1	WHEREAS, on May 07, 2004, the Legislative Council by Legislative Order No. 04-201 did appoint Rosita
2	N. Ruiz as the Legislative Council Secretary; and

5	WHEREAS, the Legislative Council's November 3, 2004 General Session agenda did include the item
6	of the Legislative Secretary Six-Month Evaluation; and
7	WHEREAS, the Legislative Branch Officers did present its evaluation on the Secretary to the
8	Legislative Council.
9	NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council does hereby rescind
10	Legislative Order No. 04-201, "Certifying the Appointment of Rosita N. Ruiz as Legislative
11	Council Secretary."
12	BE IT FURTHER ORDERED that the Legislative Branch Administration shall re-advertise the
13	Legislative Council Secretary position.

15	NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,333.6 FOR; 641.25
16	AGAINST; <u>654.85</u> NOT VOTING; and <u>[02]</u> ABSENT, pursuant to the powers vested in the Council by
17	Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
18	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
