

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Certifying the Appointment of Julianna Saraficio as Acting Legislative Secretary)**

**LEGISLATIVE ORDER NO. 04-587**

1 **WHEREAS, on May 07, 2004 the Legislative Council by Legislative Order No. 04-201 did appoint**  
2 **Rosita N. Ruiz as the Tohono O'odham Legislative Council Secretary until June 2005;**  
3 **and**

4 **WHEREAS, the Legislative Council's November 3, 2004 General Session agenda did include the**  
5 **item of the Legislative Secretary Six-Month Evaluation; and**

6 **WHEREAS, pursuant to Legislative Order No. 04-586, the Legislative Council rescinded the**  
7 **appointment of Rosita N. Ruiz as Legislative Council Secretary.**

8 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
9 **certifies the appointment of Julianna Saraficio as Acting Legislative Council Secretary**  
10 **from November 03, 2004 through June 2005 or until such time when an appointment**  
11 **for Legislative Council Secretary is made by the Legislative Council.**

12 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>, Day of**  
13 **NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,646.4 FOR; 452.55**  
14 **AGAINST; 530.75 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
15 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
18 **18, 1934 (48 Stat. 984).**
