**(Approving Tohono O'odham Department of Human Services - Division of Senior Services**  
**Administration on Aging Title VI Grant – Needs Assessment)**

**RESOLUTION NO. 04-590**

1 **WHEREAS, the Department of Human Services, Senior Services Division receives Administration**  
2 **on Aging Title VI Grant funding; and**

3 **WHEREAS, Administration on Aging Title VI Grant funding has provided ongoing and beneficial**  
4 **services to the O'odham elderly; and**

5 **WHEREAS, the Tohono O'odham Department of Human Services, Senior Services Division will**  
6 **submit an application for FY05 funding; and**

7 **WHEREAS, a requirement of the FY05 Administration on Aging grant application is a needs**  
8 **assessment in order to develop new program objectives; and**

9 **WHEREAS, the Department of Health and Human Services, Administration on Aging has awarded**  
10 **a grant to the University of North Dakota National Resource Center on Native**  
11 **American Aging to provide technical assistance on the health and social needs of**  
12 **Native elderly and to assist Tribes in conducting a needs assessment; and**

13 **WHEREAS, the needs assessment is designed to provide information on the following Native**  
14 **elder health care needs:**

- 15 • **General Health Status**
- 16 • **Activities of Daily Living**
- 17 • **Visual, Hearing and Dental**
- 18 • **Tobacco and Alcohol Use**
- 19 • **Nutrition, Exercise and Excess Weight**
- 20 • **Social Support, Housing and Work**

21 **WHEREAS, the confidentiality of our O'odham members and Tohono O'odham information is**  
22 **of the utmost importance. The information collected for the needs assessment will**  
23 **be done anonymously and the information will be stored in a locked file cabinet and**  
24 **destroyed after a three year period.**

25 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 26 **1. That it hereby approves the Nation's participation in the needs assessment as**  
27 **required by the Administration on Aging, Title VI grant application.**



The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


