

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier District Budget for the Fiscal Year beginning on
October 1, 2004 and ending on September 30, 2005)**

RESOLUTION NO. 04-592

1 **WHEREAS, the San Xavier District Council has reviewed the projected expenditures for the fiscal**
2 **year ending on September 30, 2005 and has determined that the budget components**
3 **are essential to meeting the needs of the San Xavier Community; and**

4 **WHEREAS, the San Xavier District Council intends to utilize its gaming revenues to meet the**
5 **projected budget amount outlined in the attached fiscal year 2005 budget; and**

6 **WHEREAS, the San Xavier District intends to utilize funds due to the District in the amount of**
7 **\$100,000 from the Bureau of Indian Affairs to meet the projected amount outlined in**
8 **the attached fiscal year 2005 budget; and**


9 **WHEREAS, the proposed budget and the requested 5% salary increase for the District Chairman**
10 **and Vice Chairman, have been reviewed and approved by majority vote of the San**
11 **Xavier District members present at the Special District Community meeting held on**
12 **October 30, 2004; and**

13 **WHEREAS, the total proposed budget amount is \$5,416,402.26.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby with the**
15 **authority approves the San Xavier District fiscal year 2005 budget in the amount of**
16 **\$5,416,402.26 retro to October 01, 2004.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
18 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,381.3 FOR; 612.5**
19 **AGAINST; 635.9 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**


