

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting the Executive Branch Fiscal Year 2005 Budget and Appropriating Funds
in the Amount of \$38,190,568.82)

RESOLUTION NO. 04-609

1 WHEREAS, the Executive Branch has prepared and presented its Fiscal Year 2005 budget to the
2 Tohono O'odham Nation Legislative Council; and

3 WHEREAS, the Executive Branch FY 2005 is presented in summary as Schedule 1 to the Tohono
4 O'odham Nation Fiscal Year 2005 Budget, October 1, 2004 through September 30,
5 2005, as well as in detailed budgets that by this reference are both incorporated into
6 this resolution.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the attached
8 Executive Branch Fiscal Year 2005 Budget in the amount of \$38,190,568.82 is hereby
9 approved.

10 BE IT FURTHER RESOLVED that the Legislative Council does hereby appropriate \$38,190,568.82
11 from general fund revenues to fund the Executive Branch FY 2005 Budget as
12 presented and attached.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
14 of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,816.35 FOR; 647.05
15 AGAINST; -0- NOT VOTING; and 166.3 [03] ABSENT, pursuant to the powers vested in the Council by
16 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
17 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
19 18, 1934 (48 Stat. 984).
