

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Cardiovascular Disease (CVD) Risk Reduction in Diabetes Clients Grant,
Special Diabetes Programs for Indians Competitive Grant # 1 H1D 94 00537-01
(October 1, 2004 – September 30, 2005))

RESOLUTION NO. 04-610

1 WHEREAS, the Tohono O'odham Nation has applied, and been approved to receive, \$404,000 in
2 competitive funding from Special Diabetes Programs for Indians monies; and

3 WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the
4 establishment of the Community Based Diabetes Prevention Program, funded by the
5 Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of
6 1997; and

7 WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved the
8 name change of the Community Based Diabetes Prevention Program to the Healthy
9 O'odham Promotion Program; and

10 WHEREAS, by Resolution No. 04-287, the Tohono O'odham Legislative Council approved a
11 resolution of support for the above entitled application for funding; and

12 WHEREAS, this program will be called *Ihptak Ap' e dag*, or Well Heart; and

13 WHEREAS, the Tohono O'odham Department of Human Services is requesting the Fiscal Year
14 2005 base budget of \$404,000.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:

- 16 1. Approves the Division of Health Promotion Program CVD risk reduction (*Ihptak*
17 *Ap' e dag*) program budget of \$404,000 for FY 2005.
- 18 2. The Tohono O'odham Nation Officials, to wit: the Chairwoman and Vice Chairman
19 and any designated Official are hereby authorized to negotiate and execute the
20 grant and expend funds associated with this budget.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
22 of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,288.0 FOR; -0-
23 AGAINST; -0- NOT VOTING; and 341.7 [05] ABSENT, pursuant to the powers vested in the Council by
24 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
25 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
27 Stat. 984).


