

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Authorizing Fiscal Year 2005 Initiative Administration Budgets;**  
**Appropriation of Additional Funds to the Reserve)**

**RESOLUTION NO. 04-614**

1 **WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual administrative cost**  
2 **of implementing the provisions of the initiative; and**

3 **WHEREAS, a reserve was established to fund the necessary administrative requirements; and**

4 **WHEREAS, the Executive Branch has prepared a Fiscal Year 2005 budget to continue its Initiative**  
5 **Administration, as attached in summary form as Schedule 2 and incorporated by this**  
6 **reference; and**

7 **WHEREAS, the total Fiscal Year 2005 budget, in the amount of \$1,526,352.53 includes:**

15 **WHEREAS, the estimated unexpended balance of the established reserve for fiscal year end FY04**  
16 **is projected to be \$716,575.29; and**

17 **WHEREAS, an additional amount of \$809,777.24 will need to be authorized and appropriated**  
18 **from the Nation's Gaming Revenues held in the Nation's Desert Diamond Savings**  
19 **Account to fully fund the proposed Initiative Administration budget; and**

20 **WHEREAS, the budgets have been presented to the respectable Legislative Oversight Committees**  
21 **for review.**

22 **NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 23 1. **The estimated unexpended balance of the established reserve for fiscal year end**  
24 **FY04 is projected to be \$716,575.29 is hereby re-authorized for continued**  
25 **administration of the requirements of Initiative IN-01-97.**
- 26 2. **An additional \$809,777.24 is hereby appropriated to the Initiative Administration**  
27 **reserve from the Nation's Gaming Revenues held in the Nation's Desert Diamond**  
28 **Savings Account to fully fund the Executive Branch Initiative Administration.**
- 29 3. **The Executive Branch Fiscal Year 2005 Initiative Administrative Budget,**  
30 **summarized in Schedule 2 hereto, in the full amount of \$1,526,352.53 is hereby**  
31 **approved and authorized to be expended accordingly.**

6 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
7 **18, 1934 (48 Stat. 984).**


