

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and Authorizing the FY05 Operating Budget of KOHN-FM Radio Station**  
**for the Period October 1, 2004 through December 31, 2004)**

**RESOLUTION NO. 04-615**

1 **WHEREAS, pursuant to Legislative Council Resolution No. 2000-515, the Office of the**  
2 **Chairwoman is presently operating KOHN-FM under a budget set aside from the**  
3 **Nation's savings account; and**

4 **WHEREAS, it is estimated that an unexpended balance of \$52,771.77 will remain at fiscal year end**  
5 **2004; and**

6 **WHEREAS, it is the intent of the Executive Office to continue the operations of KOHN-FM with the**  
7 **available balance of the original appropriation for which a re-authorization from the**  
8 **Nation's Legislative Council is required until December 31, 2004 pending a decision**  
9 **on the permanent placement of KOHN-FM within the Nation's government; and**

10 **WHEREAS, an additional \$47,061.07 has been approved within the Executive Branch overall**  
11 **budget to supplement the operations of KOHN-FM until December 31, 2004.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**  
13 **unexpended balance of \$52,771.77 of funds originally appropriated for the operations**  
14 **of KOHN-FM is hereby re-authorized for the continued use by the Executive Branch**  
15 **to continue the operations of KOHN-FM until December 31, 2004.**

16 **BE IT FURTHER RESOLVED that the re-authorization of these unexpended funds shall be used**  
17 **along with the supplemental appropriation made in the Executive Branch's overall**  
18 **budget for FY05.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day**  
20 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,744.2 FOR; 719.2**  
21 **AGAINST; -0- NOT VOTING; and 166.3 [05] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
23 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**


