

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and authorizing the use of Gaming Savings Funds Appropriated for the Hia-Ced O'odham by Resolution No. 03-218 for the 2005 Fiscal Year Hia-Ced O'odham Planning and Development Budget)

**DEFEATED
RESOLUTION NO. 04-617**

1 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution No. 03-218 approving**
2 **the land acquisition of the Roberts Property by the Tohono O'odham Nation for a Hia-**
3 **Ced O'odham land base and authorized the utilization of Gaming Savings funds in the**
4 **amount of \$1.8 million dollars to purchase the land; and**

5 **WHEREAS, the Roberts Property land acquisition was finalized on October 2, 2003 at which time**
6 **the Tohono O'odham Nation purchased the property in the amount of \$1.5 million**
7 **dollars on behalf of the Hia-Ced O'odham; and**

8 **WHEREAS, Resolution No. 03-218 states that any funds remaining be held in an Investment**
9 **Savings Account, to fund any unforeseen expenses for the land and that this funding**
10 **be for this sole purpose; and**

11 **WHEREAS, the Hia-Ced O'odham Program in collaboration with the Hia-Ced O'odham Advisory**
12 **Committee is requesting to utilize Fiscal Year 2004 estimated budget savings in the**
13 **amount of \$149,803.39 for the Fiscal Year 2005 Hia-Ced O'odham Planning and**
14 **Development budget.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports and**
16 **approves the Fiscal Year 2005 Hia-Ced O'odham Planning and Development budget**
17 **in the amount of \$149,803.39 to be administrated by the Hia-Ced O'odham Program**
18 **in collaboration with the Advisory Committee for the continuation on planning and**
19 **development of the land base.**

20 **The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 30TH.**
21 **Day of NOVEMBER, 2004 at a meeting at which a quorum was present, and by a vote of 953.65 FOR;**
22 **1,509.75 AGAINST; -0- NOT VOTING; and 166.3 [05] ABSENT, failed to pass because it did not receive**
23 **a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono**
24 **O'odham Nation.**
