


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing the Fiscal Year 2005 Budget for the
Economic Development Business Grants)

RESOLUTION NO. 04-624

1 **WHEREAS, Initiative IN-01-97 authorized the establishment of reserves to fund the activities**
2 **required under the provisions of the Initiative; and**
3 **WHEREAS, of the previously authorized Economic Development Business Grant program of**
4 **\$3,500,000.00, \$2,734,642.75 is estimated to remain unexpended at FY2004 year end;**
5 **and**
6 **WHEREAS, the authorization for the unexpended balance of \$2,734,642.75 will expire on**
7 **September 30, 2004, it is the intent of the Executive Branch to re-authorize these**
8 **funds as part of its FY2005 budget of \$3,500,000.00; and**
9 **WHEREAS, the proposed Economic Development Business Grant program of \$3,500,000.00**
10 **requires an additional appropriation of \$ 765,357.25 as presented in the attached**
11 **Schedule 2; and**
12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
13 **authorizes an additional \$765,357.25 from the Economic Development Grant Reserve**
14 **and re-authorizes the unexpended balance of the FY 2004 budget, \$2,734,642.75 for**
15 **Economic Development Business Grant for a total authorized amount of**
16 **\$3,500,000.00 for FY 2005 as presented in Schedule 2 attached.**
17 **BE IT FINALLY RESOLVED that the Executive Branch is authorized to expend funds pursuant to the**
18 **attached budget presented.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
20 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and 166.3[06] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


