

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing Fiscal Year 2005 Budget for Youth Recreation Center Construction)

RESOLUTION NO. 04-625

1 **WHEREAS, Initiative IN-01-97 authorized the establishment of reserves to fund the activities**
2 **required under the provisions of the Initiative; and**

3 **WHEREAS, the Executive Branch has developed a budget, in the amount of \$21,114,371.00 to**
4 **allocate funds for the design and construction of Youth Centers within various**
5 **districts; and**

6 **WHEREAS, the Recreation Construction has an estimated unexpended balance of \$21,112,746.00**
7 **which will expire on September 30, 2004; and**

8 **WHEREAS, an additional amount of \$1,625.00 will need to be appropriated to fully fund the**
9 **proposed budget of \$21,114,371.00; and**

10 **WHEREAS, it is the intent of the Executive Branch to re-authorize the unexpended balance of**
11 **\$21,112,746.00 to be expanded as proposed in the Recreation Construction FY 2005**
12 **budget presented and summarized in the attached Schedule 2.**


13 **NOW, THEREFORE, BE IT RESOLVED that \$21,112,746.00 is hereby re-authorized from the Youth**
14 **Center Project Reserve for the Recreation Center Construction FY 2005 budget as**
15 **presented in Schedule 2 attached.**

16 **BE IT FURTHER RESOLVED that an additional amount of \$1,625.00 is hereby appropriated from**
17 **the Recreation Center reserve to fully fund the proposed budget of \$21,114,371.00.**

18 **BE IT FINALLY RESOLVED that the Executive Branch is authorized to expend funds pursuant to the**
19 **attached budget presented.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
21 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,997.8 FOR; -0-**
22 **AGAINST; 465.6 NOT VOTING; and 166.3 [06] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
24 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
