Initiative IN-01-97 authorized the establishment of reserves to fund the activities required under the provisions of the Initiative; and WHEREAS, the Executive Branch has developed a budget, in the amount of \$21,114,371.00 to allocate funds for the design and construction of Youth Centers within various districts: and WHEREAS, the Recreation Construction has an estimated unexpended balance of \$21,112,746.00 which will expire on September 30, 2004; and WHEREAS, an additional amount of \$1,625.00 will need to be appropriated to fully fund the proposed budget of \$21,114,371.00; and WHEREAS. it is the intent of the Executive Branch to re-authorize the unexpended balance of \$21,112,746.00 to be expanded as proposed in the Recreation Construction FY 2005 budget presented and summarized in the attached Schedule 2. NOW, THEREFORE, BE IT RESOLVED that \$21,112,746.00 is hereby re-authorized from the Youth Center Project Reserve for the Recreation Center Construction FY 2005 budget as presented in Schedule 2 attached. BE IT FURTHER RESOLVED that an additional amount of \$1,625.00 is hereby appropriated from the Recreation Center reserve to fully fund the proposed budget of \$21,114,371.00. BE IT FINALLY RESOLVED that the Executive Branch is authorized to expend funds pursuant to the attached budget presented. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $30^{TH}$ . Day of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 1,997.8 FOR; -0-
