

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Funds in the Amount of \$50,000.00 for Youth Transportation Art Grant)**

RESOLUTION NO. 04-627

1 **WHEREAS, the Planning Department's Transportation Program received funding in the amount**
2 **of \$50,000.00 for the Youth Transportation Art Project; and**

3 **WHEREAS, the Project is funded by a grant from the Pima Association of Governments which is**
4 **to enhance community pride by involving the District youth in designing public**
5 **transportation art; and**

6 **WHEREAS, the Planning Department is requesting approval and acceptance of the funds in the**
7 **amount of \$50,000.00; and**

8 **WHEREAS, the grant will be administered by the Planning Department Administration.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 10 **1. It hereby gives the authority to expend the funds and approves the attached budget**
11 **for a total of \$50,000.00.**
12 **2. The Chairwoman or the Vice-Chairman of the Tohono O'odham Nation is**
13 **authorized to negotiate and execute the said agreement.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
15 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and 166.3 [06] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat. 984).**






