

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2005 Department of Health and Human Services Child Care and  
Development Fund and Head Start Budgets)**

**RESOLUTION NO. 04-628**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child**  
4 **Care Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head**  
6 **Start Program to provide educational, health, mental health and parent**  
7 **involvement services to children, three to five years of age; and**

8 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
9 **budgets as attached and incorporated by this reference, to be effective October 01,**  
10 **2004 through September 30, 2005 and request authorization to expend funds:**


- 11 1. **FY 2005 Child Care and Development Fund (CCDF) in the amount of \$988,132.**
- 12 2. **FY 2005 Head Start Grant in the amount of \$1,618,599.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Executive Branch is hereby authorized to expend**  
14 **funds for the programs listed herein above and as attached in the amounts indicated**  
15 **effective October 01, 2004 through September 30, 2005:**

- 16 1. **FY 2005 Child Care and Development Fund (CCDF) in the amount of \$988,132.**
- 17 2. **FY 2005 Head Start Grant in the amount of \$1,618,599.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day**  
19 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 166.3 [06] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**


