

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2005 State of Arizona Reimbursable Budget: Child and Adult Care Food Program)

RESOLUTION NO. 04-629

1 WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the
2 State of Arizona; and

3 WHEREAS, the Arizona Department of Education through the Child and Adult Care Food
4 Program Service Agreement provided reimbursement of funds for food costs
5 incurred based on the guidelines identified in the agreement; and

6 WHEREAS, the Executive Branch developed and obtained committee approval of the following
7 budgets as attached and incorporated by this reference, to be effective October 1,
8 2004 through September 30, 2005 and request authorization to expend the funds:


- 9 1. Child and Adult Care Food Program - \$40,000

10 NOW, THEREFORE, BE IT RESOLVED that the Executive Branch is hereby authorized to expend
11 funds for the program listed herein and as attached in the amounts indicated,
12 effective October 1, 2004 through September 30, 2005:

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
15 of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-
16 AGAINST; -0- NOT VOTING; and 166.3 [06] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
18 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
20 Stat. 984).
