1 **WHEREAS, the Agriculture Extension Program of the Natural Resources Department was**  
2 **awarded an Animal and Plant Health Inspection Service grant for veterinary services**  
3 **in the amount of \$75,000.00 for FY 2005; and**


4 **WHEREAS, the Agriculture Extension Program has proposed a budget in fiscal year 2005 in the**  
5 **amount of \$75,000.00 to augment its budget line items for salaries, fringe benefits,**  
6 **and indirect cost; and**

7 **WHEREAS, the Tohono O'odham Nation Legislative Agriculture and Budget and Finance**  
8 **Committees have reviewed the budget of the Agriculture Extension Program and has**  
9 **been recommended for approval by the Tohono O'odham Nation Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
11 **and approves the expenditure of the Animal and Plant Health Inspection Service**  
12 **Grant Allocation in the amount \$75,000.00 by the Agriculture Extension Program as**  
13 **detailed in the attached budget.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup>. Day**  
15 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**  
16 **AGAINST; -0- NOT VOTING; and 166.3 [06] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
18 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
20 **Stat. 984).**


