

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Cultural Affairs FY 2005 Dedicated Revenue Account Budget)

RESOLUTION NO. 04-635

1 **WHEREAS, the Tohono O'odham Nation recognizes the need to protect, preserve and manage**
2 **cultural resources on its lands; and**

3 **WHEREAS, the Tohono O'odham Legislative Council passed an Archaeological Resources**
4 **Protection Ordinance (06-84) for protection and preservation of archaeological**
5 **resources historically associated with traditional or sacred values and beliefs**
6 **important to the O'odham, and of the physical site, location or context in which**
7 **archaeological resources are found; and**

8 **WHEREAS, the Tohono O'odham Legislative Council established the Cultural Affairs Program in**
9 **1997; and**

10 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 02-240 established the Cultural**
11 **Affairs Dedicated Revenue Account (Account No. 44-1506 411) for the deposit of funds**
12 **received by the Cultural Affairs Program from outside sources and authorized the**
13 **Cultural Affairs Program to expend these funds for operational purposes consistent**
14 **with approved budgets.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **authorizes the Cultural Affairs Program to expend \$5,392 in its dedicated revenue**
17 **account as itemized in the attached FY 2005 budget.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH. Day**
19 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,293.1 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 336.6[07] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
