

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorization to Expend EPA Grant Allocation for FY 2005 of the EPA Fund**  
**Account 11-5017 Water Resources Study Program Budget)**

RESOLUTION NO. 04-637

1 WHEREAS, the Water Resources Study Program of the Natural Resources Department was  
2 awarded a continuing Clean Water Act Section 106 grant for water quality planning  
3 and management in the amount of \$160,000.00; and

4 WHEREAS, the Water Resources Study program has proposed a budget in fiscal year 2005 in the  
5 amount of \$160,000.00 to augment its budget line items for salaries and fringe  
6 benefits; and

7 WHEREAS, this budget has been reviewed by the Legislative Water Resources Committee and the  
8 Legislative Budget and Finance Committee and it is recommended for approval by the  
9 Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council acknowledges that the 5%  
11 matching amount of \$8,421 is requirement for these funds will be met through in-  
12 kind services provided by the Water Resources Study Program from the BOR PL. 93-  
13 638 grant, agreement number 98-FG-32-00800.

14 BE IT FINALLY RESOLVED that the total budget funding for fiscal year 2005 of \$160,000.00 for  
15 the Water Resources Study Program is approved in accordance with the budget  
16 attached hereto.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day  
18 of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-  
19 AGAINST; -0- NOT VOTING; and 166.3[06] ABSENT, pursuant to the powers vested in the Council by  
20 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
21 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
23 Stat. 984).


