

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Consolidated Healthy O'odham Promotion Program FY 2005 Budget
(October 1, 2004 – September 30, 2005))

RESOLUTION NO. 04-638

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**
2 **through FY 2009 with a base budget of \$1,929,827.00; and**

3 **WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of**
6 **1997; and**

7 **WHEREAS, by Resolution No. 98-150, the Tohono O'odham Legislative Council approved the**
8 **establishment of the Data Improvement Program under the Special Diabetes**
9 **Programs for Indians, authorized by the Balanced Budget Act of 1997; and**

10 **WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved the**
11 **name change of the Community Based Diabetes Prevention Program to the Healthy**
12 **O'odham Promotion Program; and**

13 **WHEREAS, the Tohono O'odham Department of Human Services is requesting the Fiscal Year**
14 **2005 base budget of \$1,929,827.00.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 16 **1. Approves the Division of Health Promotion Program Fiscal Year 2005 budget for**
17 **\$1,929,827.00.**
- 18 **2. The Tohono O'odham Nation Officials, to wit: the Chairwoman and Vice**
19 **Chairman and any designated Official are hereby authorized to negotiate and**
20 **execute the grant and expend funds associated with this budget.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day**
22 **of NOVEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,272.0 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and 357.7[08] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**






