5		party reimbursement funds collected by the Division of Health Transportation
6		Service be applied to the program's base budget for program operations; and
7	WHEREAS,	there is a need to supplement the FY 2005 tribal budget with FY 2004 Third Party
8		Revenue funds in the amount of \$760,119.27 for operational costs of the Division of
9		Health Transportation Service; and
10	WHEREAS,	the Division of Health Transportation Service has sufficient funds deposited with the
11		Nation's Accounting Department to cover the proposed budget amount of
12		\$760,119.27; and
13	WHEREAS,	a Third Party Revenue budget in the amount of \$760,119.27 for FY 2005 has been
14		submitted for review and approval by the Department of Human Services for the
15		Division of Health Transportation Service.
16	NOW, THEI	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
17		approves:
18		1. The attached FY 2005 Third Party Revenue Budget in the amount of \$760,119.27
19		to supplement the FY 2005 Health Transportation Service tribal budget.

21		Chairman and any designated Official is hereby authorized to negotiate and
22		execute the contract and expend funds associated with this budget.
