

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2005 - 2006 Department of Health and Human Services Title IV-B Budgets)

RESOLUTION NO. 04-640

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**
4 **Division of Child Welfare Services to intervene against child abuse and neglect and**
5 **to promote safe and stable families; and**

6 **WHEREAS, the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation matches**
7 **through the P.L. 93-638 master contract, specifically the BIA Social Services budget**
8 **for child welfare services and the BIA ICWA budget for Family Preservation Program,**
9 **as authorized by both P.L. 93-638 and the Department of Health and Human Services;**
10 **and**

11 **WHEREAS, these Title IV-B, Subparts 1 & 2 Budgets are developed for spending to be authorized**
12 **beginning October 1, 2004 and ending September 30, 2006, funding the two fiscal**
13 **years of FY 2005 and FY 2006; and**

14 **WHEREAS, the Department of Health and Human Services has determined an allocation**
15 **amount for these budgets as:**

16 **1. \$111,767.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1331.**

17 **2. \$107,190.00 for Title IV-B, Subpart 2 Budget, Acct. 11-1332; and**

18 **WHEREAS, the Executive Branch developed and obtained committee approval of the budgets**
19 **attached and incorporated by this reference, to be effective October 1, 2004 through**
20 **September 30, 2006 and request authorization to expend funds over the two fiscal**
21 **years of FY 2005 and FY 2006.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
23 **approve and authorize the Executive Branch to expend funds for the budgets**
24 **attached, effective October 1, 2004 through September 30, 2006, in the following**
25 **amounts:**

26 **1. FY 05-06 Title IV-B, Subpart 1 Budget, Acct. 11-1331 = \$111,767.00.**

27 **2. FY 05-06 Title IV-B, Subpart 2 Budget, Acct. 11-1332 = \$107,190.00.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairwoman,**
29 **Vice Chairman and any designated official are hereby authorized to negotiate,**
30 **execute and expend the grant.**

6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
7 Stat. 984).


