

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Human Services – Family Assistance Division - FY2005**  
**Food Distribution Program-Budget and Proposal, Account No. 11-1315)**

RESOLUTION NO. 04-643

1 WHEREAS, the Tohono O'odham Nation, Department of Human Services, Family Assistance  
2 Division is presently operating the Food Distribution Program under an FY2004 Grant  
3 with the United States Department of Agriculture; and

4 WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham  
5 Nation and the people; and

6 WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY2005 United  
7 States Department of Agriculture funds to assist eligible individuals and families with  
8 commodity foods; and

9 WHEREAS, the Tohono O'odham Department of Human Services, Family Assistance Division,  
10 Food Distribution Program has submitted for review and approval the proposal and  
11 budget in the amount of \$181,137.99.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 13 1. It hereby approves the attached FY05 Food Distribution Program budget amount  
14 of \$181,137.99.
- 15 2. That the Tohono O'odham Nation's officials, to wit: The Chairwoman is hereby  
16 authorized to negotiate and execute the grant.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> Day  
18 of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-  
19 AGAINST; -0- NOT VOTING; and 166.3 [06] ABSENT, pursuant to the powers vested in the Council by  
20 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
21 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
23 Stat. 984).
