

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Human Services Division of Behavioral Health - FY 2005 Utilizing Revenue Budget)

RESOLUTION NO. 04-645

1 **WHEREAS, the Department of Human Services, Division of Behavioral Health is currently**
2 **operating the Behavioral Health Division through an Indian Health Services (I.H.S) 638**
3 **Contract; and**

4 **WHEREAS, the Tohono O'odham Legislative Council did approve the merging of the former**
5 **Tohono O'odham Psychological Services, Division of Alcohol and Substance Abuse and**
6 **SMI programs under the Division of Behavioral Health in FY 2004; and**

7 **WHEREAS, the Division of Behavioral Health, SMI has been collecting third party reimbursement**
8 **funds since September 1999, via Resolution No. 99-500 from the State of Arizona and**
9 **has since accumulated funds in the amount of \$268,606.00; and**

10 **WHEREAS, the Division of Behavioral Health, SMI has accumulated funds to cover the Tribal**
11 **Subsidy budget in the amount of \$10,947.00 for FY 05 operational expenses (October**
12 **01, 2004 to September 30, 2005) leaving a balance of \$257,659.00; and**

13 **WHEREAS, the balance of \$257,659.00 and any future funds generated will be used for future**
14 **Program expenses.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 16 **1. That the Tohono O'odham Legislative Council hereby approves the Behavioral**
17 **Health, SMI Revenue Budget in the amount of \$10,947.00 for Operational expenses.**
- 18 **2. That the balance of \$257,659.00 and any future funds generated be used for future**
19 **operational expenses through an approved budget.**
- 20 **3. That the Tohono O'odham Nation's Officials, to wit: the Chairwoman, Vice**
21 **Chairman and any designated Officer are hereby authorized to negotiate and**
22 **execute the proposal.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST Day**
24 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and 166.3 [06] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
