RESOLUTION NO. 04-647

1 **WHEREAS, the Sells District Chairman presented the Sells District FY 2005 Administration and**
2 **Community budgets to the Tohono O'odham Legislative Council for review and**
3 **approval; and**

4 **WHEREAS, the FY 2005 Budget covers the cost for the District's Administration and Communities**
5 **in the amount of \$1,815,397.20; and**

6 **WHEREAS, the Tohono O'odham Legislative Council did review and approve the Sells District**
7 **Administration and Community Budgets.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council did review and**
9 **approve the Sells District's FY 2005 Administration and Community Budgets in the**
10 **amount of \$1,815,397.20.**

11 **BE IT FINALLY RESOLVED that the budget amount of \$1,815,397.20 will be appropriated from**
12 **gaming revenues.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01st, Day**
14 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,459.4 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and 170.3 [06] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**


