

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Fiscal Year 2005 Budget for the Tohono O'odham Nation Justice  
Branch and Appropriating Funds in the Amount of \$5,034,724.90)**

**RESOLUTION NO. 04-648**

1 **WHEREAS, the fiscal year 2004 will end at midnight, September 30, 2004 and all spending**  
2 **authority granted under the 2004 budgets terminate at that time; and**

3 **WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget to the**  
4 **Legislative Council that reflects the needs of the Branch, a copy of the proposed said**  
5 **budget is attached hereto and incorporated herein by reference; and**

6 **WHEREAS, the total amount for the FY 2005 Judiciary Budget includes the \$182,100.16 referenced**  
7 **to by Resolution No. 03-456, in which the FY 2004 budget was reduced by \$182,100.16**  
8 **as a savings for the Nation and subsequently the \$182,100.16 reduction was incurred**  
9 **by a savings carried forward under the Judicial Service 93-638 FY 2004 budget. Also**  
10 **included is a 2.5% cost of living in the amount of \$106,267.23, which is a grand total**  
11 **of \$5,034,724.90 for FY 2005.**

12 **WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative**  
13 **Council of the Tohono O'odham Nation have reviewed this budget and recommends**  
14 **its approval and adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**  
16 **has reviewed and approved the Fiscal Year 2005 budget submitted by the Judicial**  
17 **Branch, including the reinsertion of \$182,100.16 and the 2.5 % cost of living increase.**

18 **BE IT FURTHER RESOLVED that funds in the amount of \$5,034,724.90 is appropriated and**  
19 **authorized to be expended from sources of funding approved by this Council for**  
20 **support of the Fiscal Year 2005 budget of the Tohono O'odham Judicial Branch**  
21 **retroactive to October 1, 2004.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>. Day**  
23 **of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,459.4 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and 170.3 [04] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**




