2		authority granted under the 2004 budgets terminate at that time; and
3	WHEREAS,	the Judicial Branch of the Nation has prepared and presented a budget to the
4		Legislative Council that reflects the needs of the Branch, a copy of the proposed said
5		budget is attached hereto and incorporated herein by reference; and
6	WHEREAS,	the total  amount for the  FY 2005  Judiciary  Budget  includes  the  \$182, 100.16  referenced
7		to by Resolution No. 03-456, in which the FY 2004 budget was reduced by \$182,100.16
8		as a savings for the Nation and subsequently the \$182,100.16 reduction was incurred
9		by a savings carried forward under the Judicial Service 93-638 FY 2004 budget. Also
10		included is a 2.5% cost of living in the amount of \$106,267.23, which is a grand total
11		of \$5,034,724.90 for FY 2005.
12	WHEREAS,	the Judiciary Committee and the Budget and Finance Committee of the Legislative
13		Council of the Tohono O'odham Nation have reviewed this budget and recommends
14		its approval and adoption.
15	NOW, THER	EFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation
16		has reviewed and approved the Fiscal Year 2005 budget submitted by the Judicial
17		$Branch, including the reinsertion of \$182, 100.16 \ and \ the \ 2.5\% \ cost of living increase.$
18	BE IT FURT	THER RESOLVED that funds in the amount of \$5,034,724.90 is appropriated and
19		authorized to be expended from sources of funding approved by this Council for
20		support of the Fiscal Year 2005 budget of the Tohono O'odham Judicial Branch
