4		attachment); and
5	WHEREAS,	the Tohono O'odham Nation has authorized a 2.5 % cost of living increase with
6		instructions to absorb the cost from within our allocation, if possible, and if not, it
7		may be added to the budget as an increase; and
8	WHEREAS,	the Judicial Service budget provides only \$21,768.05 for operations, reducing this by
9		\$6,503.64 calculated for the 2.5% cost of living increase, which equates to a 29%
10		reduction in operational funds.
11	NOW, THER	EFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council hereby
12		authorizes funds from the Nation's resources in the amount of \$6,503.64 to cover the
13		2.5% cost of living for the Judicial employees under the P.L. 93-638 Judicial Service
14		contract totaling \$349,293.75 for FY 2005.
15	BE IT FINAI	LLY RESOLVED that the \$6,503.64 to cover the 2.5% cost of living for the Judicial
16		employees under the P.L. 93-638 Judicial Services contract be retroactive to October
17		1, 2004.
