

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2005 Commerce Committee Budget)**

RESOLUTION NO. 04-651

1 WHEREAS, the Tohono O'odham Legislative Council has submitted an FY 2005 Commerce  
2 Committee Budget for purposes of attending meetings with Arizona officials, National  
3 Indian Gaming Association (NIGA), and other Indian Gaming-related conferences and  
4 meetings; and

5 WHEREAS, this budget, as attached and incorporated by this reference, is in the amount of  
6 \$36,000.00.


7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that  
8 it approves the Commerce Committee FY 2005 Budget in the amount of \$36,000.00.

9 BE IT FURTHER RESOLVED that the Commerce Committee FY 2005 Budget shall be an  
10 operating expense of the Tohono O'odham Gaming Authority.


11 BE IT FINALLY RESOLVED that the Gaming Authority shall be billed on a quarterly  
12 basis for expenditures made pursuant to the Commerce Committee's  
13 FY 2005 Budget.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> Day  
15 of DECEMBER, 2004 at a meeting at which a quorum was present with a vote of 2,088.4 FOR; 349.9  
16 AGAINST; 191.4 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
17 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
18 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
20 18, 1934 (48 Stat. 984).


