1	WHEREAS,	out of all the causes of death, Diabetes Mellitus is 68.1 per 100,000 for O'odham
2		compared to only 10.1 per 100,000 for the United States and 29.1 per 100,000 for all
3		I.H.S. areas, thus making incidence of Diabetes Mellitus for the Tohono O'odham
4		680% higher than the overall averages for the United States; and
5	WHEREAS,	the Tohono O'odham Legislative Council did by Resolution No. 99-443, appropriate
6		funds for the initial design and construction (including project administration) of a
7		23-chair Dialysis Facility in the amount of \$2,532,002; and
8	WHEREAS,	through the contracted design and development stage the need for increased
9		capacity in the facility was identified and designed, but the initial appropriation
10		of \$2,532,002 (Resolution No. 99-443) was insufficient, requiring additional
11		appropriations; and
12	WHEREAS,	the administration of the project and initial design services expenditures, provided
13		project carry forward is \$1,699,682.83, not including interest on the principal; and
14	WHEREAS,	the Tohono O'odham Legislative Council did by Resolution No. 03-548 approve and
15		appropriate an additional \$2,400,000.00 required for design and construction of an
16		expanded 40-chair facility; and
17	WHEREAS,	the \$2,400,000.00 added to the remainder of the initial appropriation of \$1,699,682.83
18		totals \$4,099,682.83 in funding available; and
19	WHEREAS,	for FY 05 the Dialysis Clinic Budget will carry forward \$4,014,478.75.
20	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
21		approve and authorize the following:
22		1. Carry forward the Dialysis Clinic Construction Budget in the amount of
23		\$4,014,478.75 for FY 2005.
